FOR RIDERS AND AUDITORS

The undersigned assumes the unavoidable risks inherent in all horse related activities, including but not limited to the following:

That the horse may behave in ways that may result in injury, death or loss to persons on or around the equine. The equine is unpredictable and may react to sound, sudden movement, unfamiliar objects, persons or other animals. The equine may cause injuries because of the surface and sub surfaces conditions on which they are ridden. An equine may cause injury by colliding with another equine, people or objects. The injury may be caused to you, your horse or your property while participating in an equine activity because another participant may not maintain control of their animal.

The inherent risks include but are not limited to bodily injury and physical harm to horse, rider and spectator.

In consideration, therefore, for the privilege of riding, boarding and/or working around horses, participating in and/or auditing clinics at the Pennsylvania Riding Academy, under the instruction of Andrea Velas, the undersigned does hereby agree to Hold Harmless and Indemnify and further release them from any liability or responsibility for accident, damage, injury or illness to the undersigned or to any family member or spectator accompanying the undersigned on the premises.
